The purpose of this bid is to establish a price for the purchase of In-Place paving services, as needed, for the Ulster County Department of Public Works. The actual roadways to be paved will be determined by the Commissioner of Public Works. This bid also includes pavement milling services as an option.

The vendor will furnish all necessary materials, equipment and labor to accomplish the anticipated work. The anticipated work includes construction signage and electronic message boards; maintenance and protection traffic (flagging); cleaning and preparation of the existing roadway; cold planning of all intersecting roadways joints and asphalt driveways; application of tack coat, hauling of asphalt; placement and compaction of the asphalt; and temporary and permanent pavement markings. The Ulster County Department of Public Works will schedule and coordinate the project with the awarded vendor.
