WHEREAS, pursuant to Section C-11(O) of the Ulster County Charter and Section A2-5(15) of the Administrative Code, the Ulster County Legislature shall have the power to approve the execution of certain contracts and amendments in the amount of \$50,000.00 or in excess of \$50,000.00 entered into by the County; and

WHEREAS, a contract for execution by the County with Family of Woodstock, Inc. has been submitted for approval by the Ulster County Legislature, which is described below:

Department of Social Services	Family of Woodstock, Inc	Agreement to provide Domestic Violence Assistance to victims of domestic violence within Ulster County in accordance with Title XX of the Social Security Act. The services include support and advocacy with Family Court matters, support groups, crisis counseling and case management. The FIRM is the only agency licensed, certified and/or designated by NYS to provide domestic violence program services in Ulster County.
