  the pre-existing Pine Grove resort and camp complex. Located at 30 Cherrytown Road,
  Town of Rochester. (SBL#70-1-24.112)
- NYS DEC Community Manufacturing Solutions, Brownfield Cleanup Program Site # C356063 Esopus, Ulster County Draft Investigation Work Plan for Brownfield Site Available for Public Comment the public is invited to comment on a draft work plan being reviewed by the NYSDEC to investigate the Community Manufacturing Solutions site located at 115 Broadway/Route 9W in the Town of Esopus. The draft investigation work plan, called a "Remedial Investigation Work Plan" (RIWP) was submitted to NYSDEC under New York's Brownfield Cleanup Program. The investigation will be performed by Community Manufacturing Solutions LLC with oversight by NYSDEC and NYS Dept of Health. NYSDEC is accepting written comments for 30 days from August 11, 2025 through September 10, 2025. - Town of New Paltz Planning Board Lead Agency Request Horsen32 Holdings LLC for 6-lot subdivision of a 30.42 +/- acre parcel located at 50 Horsenden Road, New Paltz (SBL#78.2-3-26.112) along the southeast corner of Horsenden Road and State Route 32 within the Town of New Paltz. Located in the Residence (R-1) zoning district and is currently vacant with wooded aras and wetlands. The applicant proposes to install a new road that will provide access to 5 of the 6 new single-family residential lots, and one lot will have direct driveway access off Hosenden Road. A 15.2 acre conservation easement is proposed in the center of the parcel that would encompass much of the existing wetlands and buffer areas. All lots will be served with private wells and private septic systems.
