Presentation from The Bonadio Group

Timothy Doyle, CPA / Partner from The Bonadio Group attended the meeting (via Zoom) to give an update on the status of various deliverables and summary of billing invoices. Tim stated that a breakdown of invoices was provided to the Board today for review. From the original proposal, Tim explained that they have completed the benchmarking study, the risk assessment and the 2022 Paris filing. They continue to complete the monthly bank reconciliation and monthly financials. One of two items still in process is the 2023 Paris filing, which CJ Rioux, CFO will follow up with Tania about. Second item still in the works is the Standard Operating Procedures. Discussion was held regarding the process to create the SOP. Two items in the proposal that they are not working on, after conversations with Kevin Lynch, are strategic plan and revolving loan fund matters. Once the Board determines their strategic plan and the SOP is developed, The Bonadio Group would do the operational capacity review and recommendations. At this time the fee schedule was discussed. The Bonadio Group had been reporting on UCEDA's fiscal year rather than the contract agreement dates for budget and billings and using a carry-over method from one contract year to the next.

OFFICER REPORTS

President / CEO Report

Kevin Lynch addressed Board members stating the reason he didn't move forward with some of the work mentioned in Tim Doyle's presentation was because of the budget constraints.

iPark87 Update

Lindsay Chen, County Attorney's Office, reported that they have been working on the agreement as authorized by the Board at the last meeting.

Revolving Loan Fund Update

Kevin stated that after reporting to the Board and the Ulster County Legislature, the rollout is on a brief pause. Looking at the end of January as the new date.

CFO Report

CJ Rioux, CFO, reported that due to the inability to access e-statements or receive paper statements from M&T Bank, we do not have the November 2025 financials to report on. CJ has had a conversation to rectify the situation with the bank and we expect to have November and December 2025 ready for the next meeting. The regular loan fund payment from the remaining grantee, was made in November 2025.

A conversation was held regarding the benefit of having a second set of claims auditor eyes on all UCEDA receipts. This item will be placed on the January 2026 meeting agenda for the Board to discuss.

Brian Cahill revisited the topic of not having the November 2025 financials at the meeting, stating the issue that occurred a year to two years back when preparation of the financials fell behind. The Board wants to make sure that never happens again.

NEW BUSINESS

2026 Board Meeting Schedule

Approval to Pay Bonadio Group Invoice BN450798

Bonadio Group Invoice BN450798 was reviewed by Board members. After further discussion, it was decided the invoice summary appeared to be vague and the Board would like further details from The Bonadio Group prior to approval to pay. A request for additional clarity on the expenditures will be submitted to The Bonadio Group.

UCEDA President Transition Discussion

Board Chair, Gregory Simpson, decided to defer this topic to the January 2026 meeting.
